## **Structure Governance & Management**

#### Legal status and founding document

Southside Faith Care is a Scottish Charitable Incorporated Organisation (SCIO), regulated by a written constitution. The SCIO was registered on 3<sup>rd</sup> February 2023.

#### Recruitment and appointment of Trustees

Trustees are appointed in line with the Constitution, for three years or co-opted annually. Appropriate support and information is given to Trustees as part of their induction. Training and support needs of trustees are reviewed on an ongoing basis by the Development Lead and the Convener of the Board of Trustees.

#### **Organisational Structure**

Overall policy and strategy is determined by the Trustees on the basis of ongoing input from the participants we work with as well as staff, volunteers and supporters. The Development Lead is responsible to the Trustees for the overall day to day work of the charity. The Trustees meet six times each year to review progress and develop strategy. Day to day work can be delegated to staff of the charity.

## **Objectives**

#### **Charitable purposes**

The SCIO's purpose is the advancement of education and the relief of those in need by reason of age, ill-health, disability, financial hardship or other disadvantage.

This is achieved by:

- I. supporting positive models to enable older people to be active in the local community and society,
- 2. providing pastoral care to improve their mental and spiritual well-being and their condition of life,
- 3. involving faith communities in working together to offer social activities and events interacting with other agencies to provide information and other forms of support for older people; and
- 4. promoting and encouraging the training and education of people so that they may develop skills to assist older people.

We will meet our purposes through developing and reviewing our vision, mission, values and strategic aims

#### **Vision**

A society where every older person will have the care and support to live the life they choose.

#### **Mission**

To improve the lives of all older people through pastoral care to achieve spiritual and mental well-being based on faith values:

- we will offer activities and support to combat isolation and loneliness
- we will challenge attitudes to age and age-related conditions that stop older people living as equal members of society.

#### **Values**

**Respect** We respect older people and each other at all times

Integrity We are always honest and truthful

**Equality** We always treat everyone the same

**Ethics** We always try to do the right thing

Ambition We always strive to improve the lives of older people and create the best environment for volunteers and others involved.

**Our strategic purpose** is developing as we seek to be led by older people and work with others to co-create/co-design 'community' in order to foster a sense of belonging where none exists. A quotation from Alvin Toffler, the renowned futurist, puts this well:

"Community offsets loneliness.

It gives people a vitally necessary sense of belonging"

Our strategic aims are evolving as we work with others to

- reduce social isolation and loneliness; encourage digital inclusion/reduce digital poverty; boost mental/physical health/wellbeing; recruit more volunteers; and secure funding to meet future needs
- develop/deliver positive, bespoke local approaches articulated and led by older people to operate in the space between formal health and care services
- extend our reach into and across more communities in southside Edinburgh.

## Achievements and review of the year

Our approach to combatting social isolation and loneliness is to rekindle in older people that "vital necessary sense of belonging". Our wish is to create bespoke opportunities and choices

for older people to help them advance towards that 'destination'. In doing so, we seek to work alongside, contribute to and complement the quality of health and care provision by highlighting positive community support approaches which are tailored to the articulated needs of older people who reside in southside Edinburgh.

# Digital Inclusion / Help with Technology

During the year we witnessed the genuine need in older people, hungry for help with technology. In partnership with AbilityNet and Tap into IT, we delivered a total of 60, 2-hour sessions across 4 venues. Having piloted the initial sessions at Priestfield Parish Church, we provided further programmes there and also introduced these sessions into three new venues across the year: Mayfield Court independent living complex; Marchmont St Giles Parish Church; and, Morningside United Church.

We saw 331 total participants attend: 71% female; 29% male.

This help has meant a great deal to so many. One example is Tom, who was supported through the process of applying for a Blue Badge online, who said:

So many others were able to connect online too with family, here and internationally and to know the joy of regular contact with family and friends again. People asked to be shown

how to do practical day to day tasks online to help maintain their independence: like help to set up new mobile phones, laptops, tablets; how to do emails; do banking/ pay bills; food shopping online; online

"I want to learn how to do all of this because if you don't, you get left behind and then where will you be!" Isobel

appointments; accessing local library resources and NHS information; personal purchases; booking holidays; organise photos and documents; how to search online safely; to pursue old and new interests and so much more.

A total of **166 volunteers** helped provide digital support across the 4 venues. There were different age cohorts, ranging from people in their twenties to those in their 70s. They were highly motivated to use their digital skills to help others and were often praised and thanked by folks about how "**good**",

"patient" and "helpful" they were. One volunteer commented, "I feel really good doing this because I can see that it really does help people, and so that means a lot to me. I really like that. I feel like what I am doing matters, you know, that it's making a real difference to people, right there and then."

We invited *Police Scotland* to deliver two dedicated sessions on Scams Awareness and independently on home security. These sessions attracted considerable community interest with

**49 people attending**. Police Scotland fielded many questions from both audiences and distributed information along with key contact details.

their expertise and support in our collective and collaborative efforts this past year.

Likewise, we also thank each of the 5 venues and all volunteers for their 'gift-in-kind' generous support, provision of venue space, and their volunteer time too. These are: Newington Trinity Mayfield and Priestfield Churches; Mayfield Court, Marchmont St Giles Parish



Church and Morningside United Church. Their fulsome support has aided our efforts significantly to reach out to older people across several communities in southside Edinburgh, so that they can secure the support with technology that they need and self-identify to maintain their independence for as long as possible.

We did observe during these sessions unfolding across the year that:

- o the format of volunteers giving one-to-one I-I digital skills mentoring was effective at meeting individuals' self-identified needs.
- Volunteers excelled in this. Self-confidence levels rose in both volunteers and the participants who learned from them.
- Group sessions were highly effective too for imparting key information on how to be aware of scams and what to do and not to do, and how to avoid such situations in future and provided much reassurance.

## **Sporting Memories**

In community partnership with *Sporting Memories UK*, we started this new group in September 2024 to offer another interest. People who attend get a great deal out of this time together, reminiscing and having conversations that often lead on to different decades, places, sporting legends and often too about the sports venues they have been to over the years, and the recollections linked to those times. Listening to people's stories and



reminiscences, and all the social commentary on these times, is so interesting and so much fun too. It even prompted one volunteer to investigate a former dance hall venue in Edinburgh that boasted of a wrestling arena too within its very same walls. No longer there now, it was quite a rarity - though some recalled in jest that sometimes there is little difference between dancing and wrestling!

Next year, we plan to expand the group with a monthly visit to a local golf club, *Prestonfield Golf Club*, which is very supportive of holding *Sporting Memories* sessions there. We hope to attract Volunteer Ambassadors from the Club to encourage golfers to swell the numbers. The existing members of the group are excited by the prospect of visiting such a lovely venue and look forward to meeting potential new members too.

## **Man Friday**

This group has been running for a year with 10, and a regular core of 8, men which has been

developed by the group, is self-led and shaped by the members' interests. These have included men's health and gentle exercise, ageing well, falls prevention, and outdoor exercise, including putting, playing croquet, local short walks and social lunches, BBQs and curry nights; board games; current affairs; and a good blether, with much laughter and very importantly, general and specific peer support, all of which has contributed to the encouragement of healthier and more active lives.

All the men actively participate in its running, with roles in planning, organising and supporting activities, and sustaining their programme. Evaluation at a focus group explored how possible changes might develop and key themes to progress were captured.



The group is welcoming of new members and new interests and has much to offer in the way of peer support for men.

#### Activities piloted through the year and being re-designed

We are determined to find the best ways of tackling social isolation and loneliness that resonate with older people in our community, and which provide opportunities to enhance digital inclusion and see mental and physical health and wellbeing outcomes improve.

Below are groups we trialled for a period and decided to pause whilst we redesign them to be more effective for the future, based on observation and knowledge gained as well as insight from our community partners.

We are rethinking our approach to some activities and areas for future planning.

**'Community Art'** was an idea identified in our 2022 scoping study. This activity was volunteer led in partnership with *The Salisbury Centre* who provided the venue over an 8-week period, after which works were presented in a wonderful Community Art Exhibition. The pieces portrayed the achievements of participants in a range of artistic expression, using different materials and media.



Despite being a hugely creative and enjoyable experience for all the participants, and in a centre well equipped for its arts activities, it did not grow. Nevertheless this was hugely

meaningful to those who were drawn to it. It also provided a much valued, and valuable, opportunity for the volunteer who led this activity who was able to build a portfolio of work, capturing the creative process and many beautiful images during these sessions. We seek to work again with *The Salisbury Centre* and are to explore new ideas together in 2025-26.

information on specific needs. Four issues impacting older people's lives were dealt with by volunteers: planning, housing, informal support and help, and signposting.

Equally, the 'warm space' was appreciated by a handful of others who came along. Fine conversations were had there with individuals and among small groups.

Sessions boosted people's morale and mood and enabled them to "break the day" by coming along, and to "bide a while" with us. But, it only achieved its purpose for a handful of very grateful people (beyond being a sociable space) and did not attract sufficient or consistent numbers. On consulting users, different approaches emerged to meet social need that offered a clearer purpose.

Overall, although some activities attracted only a handful of older people, the impact on participants- individually and collectively- was 'significant'.

#### **Information Conversations**

This was a different way of providing information which was successfully piloted with a block of three, monthly information sessions in the form of short talks, held from November to January, with engaging conversations designed to aid understanding on topics such as Navigating the Care Maze, Carer Support and Power of Attorney, with community partner Home Instead, supported by speakers from Care for Carers, legal input and Age Scotland. The format of informally



gathering around a table where everyone could listen, ask questions and importantly share experience, was relaxed and unthreatening. This format encouraged a more conversational and exploratory style of engagement on these topics with the 18 people in total who attended.

People found the information imparted to be "relevant", and "useful". They told us that they had enjoyed listening to and/or sharing experiences and concerns with others in a safe and, what felt like, an intimate space. Significantly, this has whetted an appetite for more of these talk-conversations.

> We have a plan in process to bring more of these sessions to the community in 2025-26 and seek to extend this offering further to include another location and catchment within southside Edinburgh.

Crafts, Games and Soup is a new activity which just started at our Year End. As we pilot this idea, we will consider practical adjustments in consultation with others to help more people engage with and benefit from this opportunity as it evolves and to meet new people, to socialise and to have fun.

## **Transport**

We recognised access to/from activities emerged as a challenge for some individuals with mobility issues.

We're exploring ways to help improve access to our activities for next year.

#### **Our Volunteers**

An impressive total of 225 volunteers participated across all our different activities throughout the year.

The benefits experienced by volunteers were linked to each individual's motivation for volunteering. This included volunteers who

- o felt good about helping people and were highly motivated by this
- o experienced an increase in confidence, which contributed to personal development needs
- o gained experience, which helped with future employment ambitions
- o met recreational and social needs
- widened their network through participating in shared interests and found participating in activities to be

 embraced training, development and learning opportunities to upskill and/or applied existing skills and experience to assist older people in local communities.

# **Our Participants - Older People**

People who participated enjoyed many benefits:

- o increased social contact through encouragement to join in which led to,
- o extended social networks; peer support; and opportunities to enjoy shared interests with others, which contributed to supporting mental health and well-being
- o increased knowledge and learning:
  - reduced anxiety about maintaining independence in this digital age by selfidentifying what they needed to know how to do to meet their day-to-day needs
  - o felt more confident in using digital technology
  - o helped to maintain independence where they lived
  - o informed of practical information related to a broad range of health topics and support available
  - o learned new techniques and use of different materials and media to create art pieces for a community exhibition
  - learned about local connections to explore
- o improved general mental health and well-being
- o experienced an increase in motivation and felt more empowered

We extend our sincere gratitude to all the participants who sought us out and came along.

# **Our Partners in the Community**

We have built up a core of steadfast community partners this past year as highlighted in the activity summaries. All align with our values and the ambitions of older people in our community. - build on these relationships and to work more closely with these groups next year to extend opportunities to more older people; and
- to enhance our reach and range into new areas within and across southside Edinburgh.

#### **Our Funders**

We acknowledge the support of our local churches, originally the drivers of this initiative with a strong focus on all older people in our community. Partners in our development, where a shared commitment to tackling and preventing social isolation and loneliness, were AbilityNet, Tap into IT, Sporting Memories, the Salisbury Centre and our local Community Link Worker Network

In addition, we are very appreciative of the access to the accommodation we have in Priestfield Parish Church- now known as Newington Trinity Priestfield as of I<sup>st</sup> January 2025- where we use the level access café lounge and other spaces for activities, as well as having our rented office located there too.

#### **Our Staff**

Over the past year Su Millar, our Development Lead, has heightened the profile of Southside Faith Care and expanded the range and character of activities we offer. Dan Taylor joined us as Activities Co-ordinator in July and facilitates the groups as well as developing our IT and online presence. The Trustees recognise and appreciate how much the staff team achieve in part-time hours.

Finally we are conscious that our governance depends on our voluntary contribution as trustees as well as having a role in establishing the new groups and promoting the strategic work of the organisation as a whole. Over the past 12 months, 10 trustee volunteers supported our work either directly or through participation in management and steering strategic direction.

#### What we have learned

- 1. Sharing resources has been cost and time effective. Working together with appropriate community partners has enabled us to increase our capacity, extend our reach and to make a difference to older people who engaged with us.
- 2. Time is a factor. We must break hard ground and plan, promote and run activities to meet articulated needs.
- 3. We are to be patient. It takes time for our seeds to grow; for new ideas to gain a foothold. It is taking time for trust to build in different pockets of the community.

- 4. Meantime, we must build our capacity through volunteer recruitment, induction, training and development into active and meaningful volunteering roles; and, to equip and empower volunteers to work together with us to help us fulfil our plans for 2025-26.
- 5. We will apply the insights and learning we have gained form activities to our future endeavours and will continue to work with supportive community partners and volunteers to increase our capacity and reach into and across the community we serve in southside Edinburgh.
- 6. That what older people say they want, and what they say they will use, becomes irrelevant unless they themselves will participate in what they have self-identified and recommend. They are the experts at being old and have great wisdom to share.
- 7. We must endeavour to identify gaps in provision and seek cost effective solutions to local issues, like transport to help people attend activities here.

#### Financial review

#### Results for the year to 28 February 2025

The SCIO has receipts of £53,965 and made payments of £66,091 resulting in a deficit of £12,126. The total funds of the SCIO as at 28 February 2025 are £37,495 which are held in the charity's bank account. Of these funds £31,792 are restricted to use and £5,703 are unrestricted.

#### **Reserves policy**

The £5,703 held as unrestricted funds form the reserves of the SCIO. Given the funding received and secured until 2027 and the development plans, the Trustees believe the reserves are sufficient. However, the building of reserves will be monitored and the Trustees are developing a reserves policy as the SCIO consolidates its activities and develops.

## Trustee remuneration and expenses

Trustees did not receive remuneration or expenses in connection with their role in the SCIO.

# INDEPENDENT EXAMINER'S REPORT TO THE TRUSTEES OF SOUTHSIDE FAITH CARE

#### Respective responsibilities of Trustees and Examiner

# NOTES TO THE ACCOUNTS FOR THE YEAR ENDED 28 FEBRUARY 2025

#### I. ACCOUNTING POLICIES

#### Basis of accounting

The accounts are prepared on a Receipts and Payments basis in accordance with the Charities & Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended). The Statement of Receipts and Payments is a summary of all money received and paid by the Charity during the financial year. No adjustments have been made for income due not yet received, or for expenditure incurred not paid by the end of the year.

#### VAT

The Charity is not registered for VAT and, accordingly, expenditure includes VAT where appropriate.

#### Resources expended

Charitable expenditure comprises those costs incurred by the charity in the delivery of its activities and services for its beneficiaries.

Governance costs include those costs associated with meeting the constitutional and statutory requirements of the charity and include the Independent Examiner's fee.

#### **Funds**

The general funds of the Charity are unrestricted and administered on a discretionary basis under the direction of the Trustees, and in line with the objects of the charity. Any funding given to the charity for specific purposes, is held as a restricted fund.

# NOTES TO THE ACCOUNTS FOR THE YEAR ENDED 28 FEBRUARY 2025

#### **Funds continued**

#### Transfers between funds:

There were no transfers between the funds in the year to 28 February 2025.

The General Fund is the unrestricted funds of the Charity and is administered on a discretionary basis under the direction of the Trustees, and in line with the objects of the charity. The Johnnie and Hilda Gibbs Charitable Trust awarded £3,000 to further the development of the charity.

#### **Restricted funds:**

The restricted funds all part-fund Southside Faith Care to establish local, person-centred services, operating in the space between formal health and care services, and to tackle social isolation and loneliness among older people.

**Tor Christian Foundation** provides funding of £110,000 over 2.5 years, £37,965 in the year to 28 February 2025 to appoint part-time staff whose role is to establish Southside Faith Care within the local community and to identify and initiate activity groups that respond to the unmet needs of older people experiencing social isolation.

**Benefact Trust** awarded a grant of £40,000 over 3 years. The funds, of which £13,000 is the second tranche, are being used towards staff costs and training, activities development, volunteering development, promotion and equipment.

**Queensberry House Trust** awarded £15,000 in the prior year and agreed to its use being spread over 3 years to help establish a hub from which groups, activities and support for older people could be centred, in particular staff costs and training activities, volunteering and equipment. Volunteering will be a particular focus in the coming year.

**Awards for All**, the National Lottery gave Southside Faith Care £9,500 in the prior year to help our community thrive. The grant recognised the early development of the charity to put an infrastructure in place, by part-funding staff costs, premises, activities, and equipment.

The Company of Mercers Philanthropy Committee awarded £5,000 in the prior year towards the expansion of the first year development of the charity. This funding is towards staff costs, volunteers' expenses, website building and equipment.
